

COMMENCEMENT BANK SMALL BUSINESS OF THE MONTH SWEEPSTAKES OFFICIAL RULES

These are the Commencement Bank Small Business of the Month Sweepstakes (the "Sweepstakes") Official Rules (these "Official Rules"). The Sweepstakes is sponsored by Commencement Bank, 1102 Commerce St., Tacoma, WA 98402 ("Commencement Bank" or "Sponsor").

Commencement Bank is sponsoring the Sweepstakes to show its support of Small Business Month. From May through December of 2020 (the "Sweepstakes Period"), a winner will be chosen at random each month and receive prizes described in these Official Rules, including participating in a VIP experience at Cheney Stadium (the "Stadium"), home of the Tacoma Rainiers Baseball Club (the "Tacoma Rainiers" or "Club").

NO PURCHASE FROM SPONSOR IS NECESSARY TO ENTER OR WIN. ANY PURCHASE WILL NOT INCREASE AN ENTRANT'S ODDS OF WINNING.

ENTRANTS DO NOT NEED TO BE A CUSTOMER OF SPONSOR; BEING A CUSTOMER OF SPONSOR WILL NOT INCREASE OR DECREASE AN ENTRANT'S CHANCES OF WINNING.

ELIGIBILITY

The Sweepstakes is open to small businesses located in the South Sound, except where prohibited by law, that are: (a) a legally operated small business with fewer than 500 employees; (b) not a franchise; (c) currently active, lawful and have all necessary and required licenses and registrations; (d) not in competition with Sponsor; and (e) not under bankruptcy protection or have judicial liens or attachments. Additionally, all entries submitted on behalf of the small business must be: (a) 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater; (b) legally able to work in the United States; and (c) able to provide reasonable proof of being an owner or affiliate of the small business entrant.

Additionally, employees of Sponsor and Club, and each of their respective subsidiaries, affiliates, owners, officers, directors, representatives and employees, their advertising and promotion agencies, and any entity involved in the development, production, implementation, administration or fulfillment of the Sweepstakes (all of the foregoing, collectively referred to herein as "Sweepstakes Entities") and their immediate family members and/or those living in the same household of such persons, whether related or not, are not eligible to enter the Sweepstakes.

Sponsor shall determine, in its sole discretion, whether an entry meets the eligibility criteria to participate in the Sweepstakes. Sponsor's decisions regarding eligibility and all other aspects of the Sweepstakes are final and binding. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations, and is void in all geographic locations where prohibited by law.

HOW TO ENTER

The Sweepstakes shall begin on May 18, 2020 at 12:00 a.m. Pacific Time (“PT”) and shall end on November 30, 2020 at 11:59 p.m. PT (the “Entry Period”).

To enter, apply online during the Entry Period at www.tacomarainiers.com (the “Website”). Limit one (1) entry per Small Business during the Entry Period. Multiple entries will not be accepted. Neither Sponsor nor Club will be responsible for lost, incomplete, illegible, late, misdirected, stolen, or mutilated entries; technical or mechanical malfunctions; errors in these Official Rules, in any related advertisements or materials; or processing error. Sponsor may void the entry of any entrant who it believes has attempted to tamper with or impair Sweepstakes administration, security, fairness, or proper play.

Online entrants to the Sweepstakes may be given the option to receive commercial emails from the Tacoma Rainiers; however, eligibility to participate in the Sweepstakes is not dependent upon entrant’s consent to receive such emails and consenting to receive such emails will not impact an entrant’s chances of winning.

Club is not a sponsor of, or responsible for conducting, the Sweepstakes. All entry data provided via the online entry form is provided to Sponsor and Club.

MEDIA CONSENT AND RELEASE

By entering the Sweepstakes, entrants consent to participation in the Sweepstakes and further consent to Sponsor and Club obtaining, using, and transferring the entrant’s name, social media handles and/or usernames, photograph, voice and/or other likeness, submitted materials, and prize information for advertising, trade and promotional purposes in association with this Sweepstakes without notice, review, approval, or compensation, in all media now known or hereafter discovered, worldwide, unless prohibited by law. Sponsor and Club are under no obligation to use any content submitted and reserve the right to reject and/or remove your submission at any time if, in the sole discretion of Sponsor and Club, it deems the content inappropriate for the Sweepstakes.

DRAWING

Each month during the Sweepstakes Period, one (1) winner will be selected in a random drawing from the eligible entries received during the Entry Period for a total of eight (8) winners during the Sweepstakes Period. Winners will be chosen from all eligible entries received in the preceding months during the Entry Period (e.g., winner for the month of August will be selected from eligible entries received during the months of May, June and July). If a prize winner is not eligible to win, or if Sponsor and/or Club are unable to contact the winner despite reasonable effort, all prizes will be forfeited and an alternate winner may be selected. Odds of winning depend on number of eligible entries received.

PRIZES

Winners will be chosen and informed of their selection by either Sponsor or Club. Winners will receive the following prizes: (i) \$250 Visa Gift Card; (ii) \$100 We R Tacoma Team

Store Credit; (iii) VIP Experience at the Stadium as determined by Club (i.e., on-field recognition during the 2020 or 2021 Minor League Baseball season); (iv) Commencement Bank Small Business of the Month Award valued at approximately \$100 (jersey or bat); (v) Up to four (4) Summit Club Premium Tickets to a future Tacoma Rainiers regular season game on a date to be determined by Club during the 2020 or 2021 Minor League Baseball season; and (vi) Video board recognition and PA announcement at the Stadium on a date to be determined by Club during the 2020 or 2021 Minor League Baseball season. Total Package Value: Approximately US \$700.00.

Winners are responsible for any expenses incurred in connection with the prizes, including their own transportation to the Stadium. No substitution or transfer of prizes is permitted. All federal, state and local taxes on prizes are the sole responsibility of the winner. If requested, winners must execute and return (a) an Affidavit of Eligibility, (b) a Liability Release, (c) proof of business ownership or affiliation (the adequacy of which will be decided in the sole discretion of Sponsor), and (d) where legal a Publicity Release within three (3) days of notification. Failure to provide any of the foregoing may result in disqualification and/or forfeiture of the entrant and the selection of an alternate winner. Sponsor and Club reserve the right to withhold some or all of the prizes outlined above in the event that either determines, in its sole discretion, that the winner is in violation of these Official Rules or the law.

Released Parties (defined below) will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppages or any other natural disaster outside their control that may cause the cancellation or postponement of any Minor League Baseball game, event or exhibition.

RELEASE

By entering this Sweepstakes, each entrant, together with such entrant's heirs and assigns, agrees to release, discharge, indemnify, and hold harmless Sponsor, Club and the NAPBL Entities (hereinafter defined), and each of their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's shareholders, officers, directors, employees, members, licensors, assigns and agents (collectively, the "Released Parties") from and against any and all liability whatsoever from any claim or cause of action, including, but not limited to, any injury, damage or loss that may occur, directly or indirectly, in whole or in part, from the participation in the Sweepstakes or from the receipt or use of the prizes (or any portion thereof) or any travel or activity related to the receipt or use of the prizes (or any portion thereof). For purposes of these Official Rules, the "NAPBL Entities" shall mean The National Association of Professional Baseball Leagues, Inc. ("NAPBL"), each NAPBL Club, each NAPBL League, Professional Baseball Promotion Corporation, Professional Baseball Umpire Corp., Baseball Internet Rights Company LLC, BIRCO Holding Company LLC, MiLB Enterprises LLC, MiLB Enterprise Holdings LLC, Minor League Baseball Charities, and each of their subsidiaries or affiliated entities, any entity which, now or in the future, controls, is controlled by, or is under

common control with the NAPBL and the NAPBL clubs and leagues, and all officers, directors, employees, agents, partners, and members of those entities. The NAPBL Entities may also be referred to as “Minor League Baseball” or “MiLB” throughout these Official Rules.

By entering this Sweepstakes, each entrant gives his, her or its express permission to be contacted by Sponsor and/or Club by telephone, email and/or postal mail for Sweepstakes purposes.

GENERAL RULES

This Sweepstakes is governed by and subject to the laws of the United States and the state of Washington. All federal, state and local laws and regulations apply. Void where prohibited by law. Winners may receive an IRS 1099 form for the value of their prizes. Entrants agree to be bound by these Official Rules and the decisions of Sponsor and/or Club, which are final and binding on all matters relating to the Sweepstakes. Neither Sponsor nor Club is responsible for any typographical or other errors in the printing of the offer, administration of the Sweepstakes or the announcement of the prizes, or for lost, late, misdirected, damaged, incomplete or illegal entries. Sponsor and Club reserve the right, in their sole discretion, to disqualify any entrant found to be (a) tampering or attempting to tamper with the entry process, (b) submitting any fraudulent materials to Sponsor and/or Club or committing any fraudulent act as part of the promotion, or (c) violating these Official Rules in any way.

DISPUTES/GOVERNING LAW

Except where prohibited, as a condition of participating in this Sweepstakes, each entrant agrees that any and all disputes that cannot be resolved between the parties, and all claims and causes of action arising out of or connected with this Sweepstakes or any prize(s) awarded, or the determination of winners, shall be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will any entrant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental or consequential damages, or any other damages, including attorneys' fees, and each entrant further waives all rights to have damages multiplied or increased. All issues and questions regarding the rights and obligations of entrants in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the state of Washington, without giving effect to the conflict of laws rules thereof.
