

**CLEAR CREEK RV HIT IT HERE SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

ELIGIBILITY: The Clear Creek RV Hit it Here Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older (except in the case of legal residents of certain states where the legal age of majority is greater than eighteen (18) years of age, such legal age of majority) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Clear Creek RV ("Clear Creek RV" or "Sponsor"), the NAPBL Entities (defined below), the MLB Entities (defined below) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win the Prize (defined below). The "NAPBL Entities" shall mean The National Association of Professional Baseball Leagues, Inc. ("NAPBL"), each NAPBL Club, each NAPBL League, Professional Baseball Promotion Corporation, Professional Baseball Umpire Corp., Baseball Internet Rights Company LLC, BIRCO Holding Company LLC, Minor League Baseball Charities, MiLB Enterprises, LLC, MiLB Enterprise Holdings, LLC and each of their subsidiaries or affiliated entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the NAPBL and the NAPBL clubs and leagues, and all officers, directors, employees, agents, partners, and members of those entities. The "MLB Entities" shall mean the Office of the Commissioner of Baseball ("BOC"), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. ("MLBAM"), The MLB Network, LLC, Major League Baseball Properties, Inc., the Major League Baseball Clubs ("Clubs"), MLB Professional Development Leagues, LLC ("MLBPD"), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States and the District of Columbia, and where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: The Sweepstakes will take place on Saturday and Sunday home games at Cheney Stadium (each, an "Eligible Game") during the period commencing Thursday, May 6, 2021 and ending Monday, October 18, 2021 (the "Sweepstakes Period"). Entrants may submit entries beginning two (2) hours prior to game time of each Eligible Game and ending after the third (3rd) inning of each Eligible Game (each, an "Entry Period"). Online entries only. No other method of entry will be accepted. Limit one (1) entry per person/email address/household. Additional entries beyond the specified limit will be void. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void. All entries must include a

valid address for the entrant. No purchase necessary to enter. Entrants to the Sweepstakes may be given the option to receive commercial e-mails from Clear Creek RV, Tacoma Rainiers, MiLB.com and/or MLBPD; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to receive such e-mails will not impact any entrant's chances of winning.

RANDOM DRAWING: If a Tacoma Rainiers player hits a batted ball through the netting portion of the Clear Creek RV sign (the "Sign") during an Eligible Game, a potential winner of the Sweepstakes will be selected by random drawing on that respective Eligible Game, from among all eligible entries received during the Entry Period for such Eligible Game. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner will be declared the official winner of the Sweepstakes (the "Winner"). The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received.

PRIZE: One (1) Prize Will Be Awarded. If a Tacoma Rainiers player hits a batted ball through the netting portion of the Sign during an Eligible Game, one (1) Winner will be selected per respective Eligible Game. The Winner will receive a mutually agreed upon RV subject to the terms and conditions associated with its use (expires October 18, 2021), determined by Sponsor in its sole and absolute discretion (the "Prize"). (Approximate Retail Value of Prize: \$25,000.00.) Exact Prize details will be determined in the sole and absolute discretion of Sponsor. The Winner is fully responsible for any and all applicable federal, state, territory, provincial and local taxes (including income and withholding taxes). The Prize is non-transferable and non-assignable, with no cash redemptions except in the sole and absolute discretion of Sponsor. Sponsor reserves the right to substitute the Prize (or any portion thereof) with a prize of comparable or greater value in its sole and absolute discretion.

NOTIFICATION: The potential winner will be notified at the e-mail address, postal address and/or telephone number (in the sole discretion of Sponsor) provided at the time of entry (the "Prize Notification"). In the event that any potential winner does not respond to any such Prize Notification within two (2) days of the date of issuance or declines the Prize for any reason, a disqualification will result, the Prize will be forfeited and, in the sole and absolute discretion of Sponsor and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. The potential winner may be required to submit his/her valid social security number and/or other identification to Sponsor and may be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, publicity, within five (5) days of the date of issuance. Failure to submit any identification required by Sponsor or to return the required documents within the specified time period, noncompliance with these Official Rules or the return of the Prize (or any portion thereof) or Prize Notification as undeliverable may result in disqualification and Prize forfeiture and, in the sole and absolute discretion of Sponsor and time permitting, may cause an alternate potential winner to be randomly selected from among all remaining eligible entries.

all other companies associated with the Sweepstakes, and all of their respective officers, directors, employees, agents and representatives (collectively, "Released Parties") for any injury, damage or loss that may occur, directly or indirectly, in whole or in part, from the participation in the Sweepstakes or from the receipt or use of the Prize (or any portion thereof) or any travel or activity related to the receipt or use of the Prize (or any portion thereof). By entering this Sweepstakes, each entrant gives his/her express permission to be contacted by the Sponsor and/or the MLB Entities by telephone, e-mail and/or postal mail for Sweepstakes purposes. The Winner, by acceptance of Prize, grants to Sponsor, the NAPBL Entities, the MLB Entities and each of their respective designees the right to publicize such Winner's name, address (city and state of residence), photograph, voice, statements and/or other likeness and Prize information for advertising, promotional, trade and/or any other purpose in any media or format now known or hereafter devised, throughout the world, in perpetuity, without limitation and without further compensation, consideration, permission or notification, unless prohibited by law.

Released Parties (i) make no warranty, guaranty or representation of any kind concerning the Prize (or any portion thereof), and (ii) disclaim any implied warranty.
